## PRESIDENT'S REPORT

The year has flown past very quickly and the committee has had a very busy year and I want to thank all members of the management committee for their commitment and their support during the year. Without their dedication, hard work and timely advice, it would not have been possible for us to achieve what we have. Rod Newman is not standing for re-election. We thank him for his contributions on the Committee. Rod is taking time out.

On a sad note, we recently had to farewell our very good friend and staunch committee member David Huntley. David passed away on the 19th of September following a period of ill health. Also, on the 10th of October we lost Alf Handley in a tragic accident on the Sunshine Coast. Most of us here have known Alf for a long time and have admired his willingness to help others. He was a soldier's soldier. As a previous president of this Association, Alf provided me with a genuine friendship and his wise counsel was always appreciated. He was a man with a great sense of humour and his loss is immense. We will miss him as a friend. He may be gone but he will never be forgotten.
We have lost quite a number of our warriors since the last AGM and we pass our thoughts and prayers to the families of those who have left us. There are also a considerable number of our members who are in poor health. I would like to pass on the Association's best wishes and our hope for a speedy recovery.
I attended the RAR Corporation AGM and National Council Meeting at the Infantry Centre in Singleton on 13-14 December last year. A number of important issues were discussed and most of the relevant information has been disseminated via our newsletter Ringo. I will again attend this conference in Singleton at the end of November this year.
2014 has been a busy year and the Secretary and I attended the RAR North Qld dinner in Townsville in February this year. The North Qld Rep, Jock Cassidy and Kiwi Gibbons also attended. This visit also gave us an opportunity to meet with and hold discussions with the new CO 2RAR: LTCOL Michael Bassingthwaighte, DSM.
In April, the 2RAR Association was focussed on the Adelaide reunion and commemorative services. The reunion primarily honoured six South Australian members of 2RAR who were KIA or died of illness whilst serving with the battalion in South Vietnam during the two operational tours 1967/68 and 1970/71. There was also a ceremony, which involved the unveiling and dedication of the 2nd Battalion, The Royal Australian Regiment Memorial on the Pathway of Honour at the Torrens Parade Ground. Sadly, Tom Young, the organiser of the Adelaide reunion, passed away suddenly on the 20th of March. A number of 2RAR Association members attended his funeral held in Adelaide on 27 March. I would like to pay tribute to Tom who had worked so hard during the previous 12 months to ensure that all aspects of the reunion would run smoothly. The reunion culminated in some 140 ex2RAR members marching through Adelaide on ANZAC Day under the 2RAR Association banner followed by a lunch at the British Hotel. It was a fitting finale to an outstanding reunion. My thanks go to all members and partners who attended the activity. A special thanks goes to our Secretary, Gordon Hurford, who picked up the major workload to ensure this reunion was a success.

Since our last AGM, I am pleased to announce that we have appointed two new members to the committee of management. Mr Ross Bimrose has recently joined us and he is currently looking at the Association's
constitution, especially our Vision Statement and Objectives. We have formed a sub-committee to look at this issue. The Association further welcomes the appointment of Mr Cameron Simpkins as our new Tasmanian representative.

The Association also gives a warm welcome to the following, who have been invited and have accepted the appointment as honorary members:

- Mr Campbell Newman — his father was operations officer 2RAR first tour Vietnam 1967/68;
- Mrs Tiffany Young — widow of Mr Tom Young organised the SA reunion in April this year; and
- Mrs Audrey Scatchard - widow of Mr Bernie Scatchard who rendered long and loyal service as our Tasmanian representative.

The Association website is now nearing completion following a number of glitches. The new website will contain a host of information and you will be advised when it goes on-line. Also, the Association is currently examining the possibility of adding some merchandise directed at the ladies. We have asked a number of the members' wives to form a committee to examine this issue.

Following discussions earlier this year with CO 2RAR, the Association agreed to assist the Battalion with the renovation of their unit museum at Lavarack Barracks, Townsville. The Association has donated $\$ 5000$ towards this project. I attended the 2RAR Battalion birthday activities in Townsville on 18 October and was present for the unveiling of the refurbished museum.

A review was recently undertaken of The Royal Australian Regiment's National Memorial Walk at Gallipoli Barracks, Enoggera, by the RAR Association (Qld). The Contemplation Building within its precinct is now some 16 years old and is in urgent need of refurbishment, extension and weatherproofing to extend its usage life for at least another 25 years. However, as a priority, it was considered essential to replace the existing decrepit pews and chairs with 27 special to purpose pews, which will add to the reverence of our Regimental spiritual home. The 2RAR Association agreed to assist with this project and has donated $\$ 1000$ towards to purchase of new seating. I also want to thank a number of our Association members who form part of "Dad's Army" and help with the maintenance of the Memorial Walk each week.

We have started some initial planning for the next major 2RAR Association reunion, which at this stage is programmed for May 2017, and is likely to be held in Brisbane. We would like to encourage all members and potential members to put this event in their diary. It is planned to develop a four-day event, which will coincide with the 50th anniversary of the departure of 2RAR to Vietnam on the HMAS Sydney. This will however not be a specific Vietnam veterans' reunion as we would like all those who served with the Battalion to attend.
Our membership continues to hover around the 550 and we would like to see that increase. There are a lot of ex2RAR servicemen out there and we would like to invite more of them to come and join us. If you know of any ex2RAR members in your area who have not joined, I would appreciate if you could encourage them to become part of this Association. All too often we seem to concentrate on the veterans with overseas service when we should be encouraging all members who served with Battalion to become part of 2RAR Association family. We especially would like some of the post-Vietnam generation to come and join us. So if you know of any exmember, let's see if we can get them on board.

In conclusion, I would like to thank the Committee for a wonderful effort in putting together this reunion. I would also just like to acknowledge the work undertaken by a number of spouses/partners throughout the year and especially at the various functions. Again, their dedication and support is very much appreciated.

## INDEPENDENT AUDITOR'S REPORT

## Scope

I have audited the attached financial statements, being a special purpose financial report of the $2^{\text {nd }}$ Battalian The Royal Australian Regiment Association Qucensland Division Inc for the year ended 30 September 2015 comprising 'Statements of Income \& Expenditure',' Balance Sheet and accompanying Notes'. The special purpose financial report has been prepared for distribution to the members of the Association for the purpose of fulfilling the Committee's accountability requirements. I disclaim any assumption of responsibility for any reliance on this report or on the financial statements to which it relates, to any person other than the members, or of any purpose other than that for which it was prepared.

My audit has been conducted in accordance with Australian Auditing Standards. My procedures included examination of evidence supporting the amounts and other accounting estimates. These audit procedures have been undertaken to form an opinion as to whether in all material respects, the financial report is presented fairly in accordance with the accounting policies deemed necessary by the Committee.

The audit opinion expressed in this report has been formed on the above basis.

## Qualification

As is common for associations of this type, it is not practicable to maintain an effective system of internal control over donations, subscriptions and other fund raising activities until their initial entry in the accounting records. Accordingly, my audit in relation to these activities was limited to amounts recorded.

## Explanatory Note:

In particular, the Association saw the need to clearly identify that the Association was an inclusive organization for all members of 2RAR regardless of whether they had served overseas or not. At present, it could be interpreted that all those members who served from 1975 to Timor are basically not represented in the Association. This amendment to the Objects of the Association modernises the purpose of the Association

(5) Cheques for petty cash reimbursement shall be made payable to "Cash" and authorized by two Signing Officers. Payments by cash are not to exceed $\$ 100$ for any one payment.
