PRESIDENT'S REPORT

It has been a busy year and I would like to acknowledge the hard work of all committee members. It is the dedication of the committee that makes this Association the success that it is. Our Patron, Colonel John Church, DSO, (Retd) has offered his apologies but due to medical reasons, he is unable to attend.

Many of you will know our past President and recent Vice President of the Association, Mr Kevin "Dasher" Dean, OAM, a Korea veteran, who was recently hospitalised. He underwent a major operation and is back on the road to recovery. Kevin said that during his hospital stay he didn't realise he had so many friends. Regrettably, due to his current health condition, he has had to resign from the Management Committee. Kevin has been an outstanding president and committee member and his contribution was recognised with him being awarded life membership to the 2RAR Association. Kevin's support to the Association has been exceptional and on behalf of all members, I would like to thank him for his dedication throughout the years. His advice and guidance have been invaluable. We pray for a speedy recovery and wish him well.

The Association congratulates the Reverend Monsignor Eugene Harley, our Honorary Padre, on being awarded the Medal of the Order of Australia (OAM) in the General Division earlier this year. As well as having delivered long and loyal service to the Australian Army, Eugene has continued to provide outstanding service to the community through the Catholic Church. It is very satisfying to see that his outstanding contribution has been justly acknowledged. Regrettably, Eugene had prior pastoral commitments in Sydney today and is unable to attend. He asked me to pass on his apologies.

We have lost quite a number of our 2RAR warriors since our last AGM and I would like to extend the Association's condolences to the families and friends of those who have marched out. Our thoughts are also with those who continue to struggle as a result of their service and wish them well. While we endeavour to have a 2RAR representative at the funeral of all ex 2RAR members, this is not always possible. If you are aware of one of our brothers passing on, please let the Secretary know so we can let all our members know.

I attended the annual RAR Corporation AGM and conference, which was held at Gallipoli Barracks Enoggera, 31 August to 2 September this year. A number of issues regarding both serving soldiers of the Regiment as well as veterans were discussed and the updated Action Plan will be placed on the 2RAR Association website.

It was good to see that during 2015, there we a number of 2RAR company and platoon reunions within Australia. If you are planning such an event, please let the Association know, as we might be able to assist. Also during the year, a number of our members represented the 2RAR Association at various memorial services throughout Australia. ANZAC Day 2015 was extremely well supported. The march through Brisbane saw some 60-70 2RAR Association members on parade.

The Secretary and I took the opportunity to represent the 2RAR Association at the RARA (North Qld) annual dinner held at the Townsville RSL on 21 February 2015. During our trip we took the opportunity to visit 2RAR at Lavarack Barracks and held informal discussions with the CO 2RAR, LTCOL Michael Bassingthwaighte, DSM and his staff. We were given a tour of the unit museum, which has been refurbished, and the Battalion continues

to upgrade this wonderful facility. Once completed, this will be a first class museum. We also visited the 2RAR combined officer/SNCO club "The Church". Our Association representative, Jock Cassidy, continues to work closely with 2RAR to seek ways in which we can support battalion activities. We have agreed to provide prizes to the value of \$400 for the unit fishing competition, which has been held during the year. The Secretary received a letter from CSM Spt Coy thanking the Association for its support. The Association also provides an annual award to the Battalion Champion Soldier.

The sponsorship arrangement with a number of hotels in the ALH group continues. There is one venue on the Sunshine Coast and two in Townsville, which are participating. Earlier this year we issued 500 Sponsorship Cards to 2RAR and encouraged them to attend the venues. We will have a better idea of progress by the end of this year. I will ask the Secretary to provide some additional information.

The Association welcomed the new 2RAR RSM, WO1 Trent Morris, who marched in mid-year. We also farewelled the outgoing RSM, WO1 Brian Buskell, CSM, who provided outstanding support to the Association during his tenure with the Battalion. 2RAR has had an extremely busy year continuing to progress the Amphibious Ready Element Landing Force capabilities. The Battalion was involved in exercise TALISMAN SABRE conducting amphibious operations with the US Marines.

At the conclusion of a number of SEA SERIES of exercises the Battalion will be involved in the 70th birthday of the founding battalions of the Regiment to be held in November. October 2015 marks the 70th Anniversary of the formation of the 65th, 66th and 67th Battalions, later to be the 1st, 2nd and 3rd Battalions, The Royal Australian Regiment. These three Battalions will hold a Ceremonial Parade at Lavarack Barracks, Townsville, on the 23rd November 2015. 2 RAR and 3 RAR will be presented replacement colours by the Governor General His Excellency General the Honourable Sir Peter Cosgrove, AK, MC, whilst the 1st Battalion will be awarded the Unit Citation Streamer for the Republic of Vietnam Cross of Gallantry with Palm. This will be a magnificent event and there is an open invitation to attend this unique occasion. For those attending dress will be coat and tie with medals where appropriate.

Our membership continues to hover around the 550 and we would like to see that increase. We continue to seek ways to increase our numbers. We really need to encourage the post Vietnam generation to join our Association and we look for any assistance in this matter.

The Management Committee has agreed that there should be a National Reunion in 2017 of all who served in 2RAR and 2/4RAR. This is 5 years since the previous reunion, which was held in Townsville in July 2012. A reunion committee has been established and comprises:

The reunion will be held in Brisbane in the May/June period. Specific dates are yet to be determined, as we want to coordinate with the Brisbane City Council and other community organisations so that we do not stage our event at the same time, as some other large event is likely to take place. The reunion will be over 3 or 4 days depending on the reunion program content.

- · Reunion dinner
- Commemorative service possibly in conjunction with the National Memorial Walk at Enoggera
- At least one other activity as a reunion group

We will endeavour to keep the costs as low as possible. Sponsorship is also being sought so if you know some business that can throw in some dollars to offset the costs, please let us know. We need to promote this to all ex-servicemen of the battalion and definitely families are encouraged to attend as well. We will use whatever systems we have to get the word out and to encourage attendance. We will also be inviting the NZ ex-members as well. The committee will meet regularly and there will be bulletins issued after the meeting to keep everybody informed.

As you may be aware, Terry Dinneen has been working for some years to try and locate a number of missing 2RAR 2nd tour Vietnam AARs. I would like to commend Terry on the considerable work that he has undertaken and I will ask him to provide an overview during general business.

Our state and territory reps continue to do good work in our regions. I would like to pass on the Association's gratitude to those members for their continued good work on behalf of the Association. Jim Cooper, the 2RAR Association Victorian rep has provided a report for this year.

Finally, the 2RAR Association Committee has done a wonderful job in putting together all aspects of this weekend's reunion. Rick Hollingdrake and his team have worked hard to ensure a successful event. I would also like to acknowledge the considerable work undertaken by the committee during the year. The dedication and hard work of all members continues to be outstanding and is very much appreciated. Furthermore I would like to

thank those spouses/partners of the committee members who continue to assist throughout the year at the various functions.

INDEPENDENT AUDITOR'S REPORT

To the Members of 2nd Battalion The Royal Australian Regiment Association Inc For the Year ended 30 September 2016.

Scope

I have audited the attached financial statements, being a special purpose financial report of the 2nd Battalian The Royal Australian Regiment Association Queensland Division Inc for the year ended 30 September 2016 comprising 'Statements of Income & Expenditure',' Balance Sheet and accompanying Notes'.
